Act III Vocabulary

T A K E N O T E S

- Contempt(uous): to disobey (esp. in court)
- Affidavit: a sworn statement of fact
- Deposition: a written testimony
- Plaintiff: the person who files suit in court (opp. of defendant)
- “Clap me” = to arrest in chains
- Prodigious: great in size or degree
- Effrontery: shameless boldness of character
- Bewildered: confused
- Ipso facto: the inevitable result of an action
- Perjury: lying under oath
- Lecher(y): a man given in to sexual indulgence
- Harlot: prostitute (also “whore”)
- Denounce: to give up; surrender

Character Log: Judge Danforth

T A K E N O T E S

- One of the major judges in the Salem Witch Trials
- Made a tad “eviler” in the play vs. real life
- Judge Stoughton was conducting the trials by the time Danforth arrived
- Danforth actually felt bad for those accused and re-located many of those accused to his farm in Boston

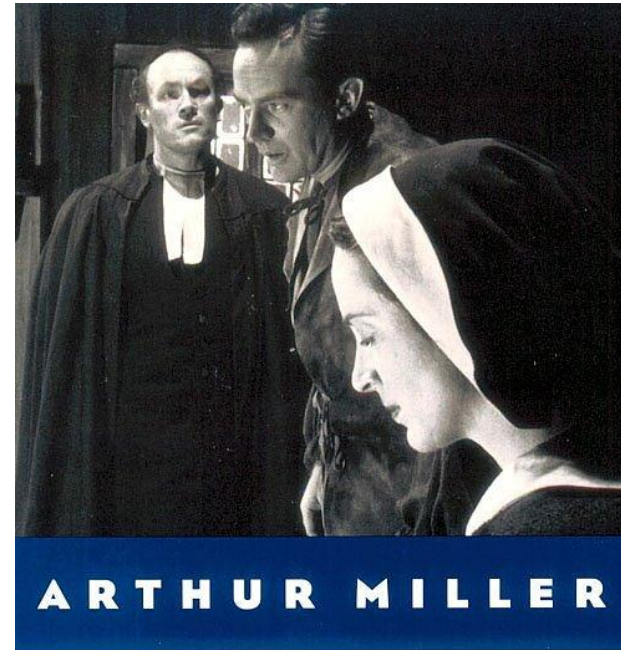
