

- Answer? Both use idiomatic expressions



Idiomatic Expressions

- Idiomatic expressions are nonsense if taken literally:
 - "That's cool"
 - "That paper burned up"
 - "Geometry goes over my head"
 - "I have butterflies in my stomach"
- To speakers of other languages, idioms are puzzling, but to native speakers, they are natural parts of conversation
- To fix: replace idiom with literal word(s) or phrase(s)
 - Bit the bullet = died




